Order of Adoption

Pharmacy Technician Fees

Amend 16 CCR § 1749(c) Fee Schedule as follows:

§ 1749. Fee Schedule.

The application, renewal, penalties, and other fees, unless otherwise specified, are hereby fixed as follows:

(c) The fee for the issuance of a pharmacy technician license is <u>one hundred</u> twenty dollars (\$120) one hundred ninety-five dollars (\$195). The fee for the biennial renewal of a pharmacy technician license is <u>one hundred fifty dollars</u> (\$150) one hundred ninety-five dollars (\$195). The penalty for failure to renew is <u>seventy-five dollars</u> (\$75). ninety-seven dollars and fifty cents (\$97.50).
