RE: PUBLIC COMMENT

Dear Board,

I am appearing for you today to provide public comment for the SIXTH time:

November 2023, December 2023, April 2024, July 2024, November 2024, December 2024

At every meeting, I provided public comment about the dangers of the COVID19 Vaccine, and asked for an agenda item at a future meeting to discuss halting this dangerous pharmaceutical product in California pharmacies. I provided you with the total number of VAERS Reports submitted FROM A CALIFORNIA PHARMACY. I gave you the number of deaths reported after a vaccine administered at a California pharmacy as of that meeting date (totals including all vaccines administered by pharmacies). This information is publicly available from the CDC through their WONDER system, OR from medalerts.org a search engine developed by the National Vaccine Information Center.

I am now providing data on the administrative errors for the first time. These problems include: product administered to patient of inappropriate age, Wrong product administered, Wrong patient received product, Incorrect route of product administration, Incorrect dose administered, Product preparation issue, Underdose, Expired product administered

For the 86 Product administration errors/issue reports for CHILDREN under 6, I am providing ALL OF THE INDIVIDUAL REPORTS that are available to the public. These include as much detail about each individual case as made public. The public cannot get location or name of the pharmacy or patient. But you do get vaccination date, vaccine name and manufacturer including lot # and dose, patient symptoms if any, and the written narrative submitted by the pharmacy.

I WOULD BE WILLING TO TRAIN ANYONE ON YOUR STAFF ON HOW TO RUN REPORTS FROM MEDALERTS. AND I WOULD BE WILLING TO BET THE BOARD CAN ACCESS THE FULL REPORT DETAIL INCLUDING NAME OF PATIENT AND PHARMACY.

Remember, I have my own VAERS Report filed, and have one filed for my Mom's vaccine death. So I know the process and the codes. I also worked for public health so I know what information is required to be submitted and can confirm they do have access to the full detail.

IF YOU AS THE CONSUMER PROTECTION AGENCY CANNOT ACCESS THE DATA ON THE PHARMACY THAT ARE COMMITTING EGRIGOUS ERRORS AND REPORTING THOUSANDS OF SERIOUS INJURIES INCLUDING 87 DEATHS, YOU NEED TO HAVE YOUR COUNSEL DEMAND ACCESS.

As a reminder, my background includes:

- **25 years as an HR Executive in Silicon Valley managing health plan contracts**
- **7 years as a Healthcare worker at Enloe Medical Center in Chico, CA (forced to resign after they mandated a booster that could kill me); roles included Patient Ambassador, Gift Shop Liaison/Fundraiser, and Chair of Events for the Volunteer Services Board of Directors**
- **1 year working for Butte County Public Health at the COVID 19 vaccination clinics (time ended when volunteers no longer needed); roles included non-medical nurse helper (passed out syringes to nurses at rate of 200/hour), help with vaccination card administration and assisting draw room nurses filling syringes**
- **Recently assigned to VAERSAware.com as Lead Investigator helping victims file and find their VAERS Reports, and provide VAERS data to researchers and doctors (I am named on a published report with Dr. Peter McCullough and Dr James Thorp proving these products are harmful to pregnant women and are causing fetal demise).**
- **I am permanently disabled after the two shots of Moderna caused brain fog diagnosed as microangiopathy (capillaries compromised by the spike protein), chronic tinnitus, and two detached retinas (requiring three emergency retina procedures and two cataract surgeries that are a result of the retina procedures)**
- **My Mom was killed by four shots of Moderna in Santa Clara County and has a VAERS Report PLUS an open federal Counter-measure Injury Compensation Plan (CICP) Claim filed through Health Reporting and Services and Administration (HRSA). Both Congressman LaMalfa and Ro Khanna are aware and assisting me with this claim.**

I ran for Butte County Supervisor in 2024 in order to hold Butte County Public Health accountable. While I lost, I did get some PR and garnered over 3,000 votes. I was a lead for the Butte County for Kennedy Campaign and am off to his Inaugural Ball in DC.

I have given public comment at over 40 Butte County Supervisor meetings trying to implore them to stop these vaccines and help victims. I have recently began traveling to OTHER counties with Ronald F Owens Jr (Glenn, Nevada, Plumas, Santa Clara, Colusa, Marin, Tehama, Lake, Sacramento, Sutter and Shasta County).

THIS IS MY HILL. I WILL NOT STOP UNTIL THESE PRODUCTS ARE STOPPED, ALL MANDATES ARE REMOVED AND VICTIMS RECEIVE HELP.
